NABERS tools are simple, reliable and trusted, helping building operators accurately measure the environmental performance of their facility and identify areas for improvement.

For 25 years, the NABERS program has driven significant financial growth and returns across building sectors, proving that environmentally friendly buildings are not only better for people and the planet; they're also better for the bottom lines of Australian businesses.

CLIMATE ACTIVE CARBON NEUTRAL CERTIFICATION FOR DATA CENTRES

A NABERS Energy rating helps data centre owners and managers track emissions and make improvements to their building's energy performance. Carbon Neutral certification goes a step further, recognising other sources of carbon emissions created from the building's operations, including energy, waste and refrigerants.

If your data centre has a NABERS Energy rating of four stars or above and uses carbon offsets to cancel the building's emissions, you can achieve a Climate Active Carbon Neutral certification. This world-leading, government-backed certification is aligned to national and international greenhouse gas accounting protocols, demonstrating excellence in sustainability.

HOW CAN I GET CARBON NEUTRAL CERTIFICATION FOR MY DATA CENTRE? If you have a NABERS Energy rating of four stars or above and use carbon offsets to cancel the building's emissions, you can achieve Carbon Neutral certification. You can choose to use renewable energy for your stationary energy consumption instead of carbon offsets.

If your data centre is below four stars you can still obtain a carbon neutral rating if a commitment to achieve three stars within three years from the start of the carbon neutral certification is made. See the NABERS Carbon Neutral Technical Guidance Document for more information.


IMPROVE ACCOUNTABILITY
